With the purchase of the "Complete Coverage" guests can cancel their trip for any reason, no questions asked! Simply call us at any time prior to airport check-in to cancel. In addition, "Complete Coverage" includes important insurance benefits and access to 24-hour emergency assistance while you are traveling.

### Why purchase "Complete Coverage"? It Includes:

#### Features provided by Funjet Vacations under the Penalty Waiver.

- \* **Cancel For Any Reason:** You may cancel for ANY reason prior to airport check-in and receive a full refund less the cost of the "Complete Coverage" plan.
- \* **Get Your Money Back:** All penalties will be waived - Funjet Vacation penalties, hotel, supplier and airline penalties, including non-refundable airfares (booked through Funjet Vacations).
- \* **Price Guarantee:** Guarantees the lowest advertised price if the price of your exact vacation increases or decreases. Only valid on vacations including Charter/Value Flights. See below for more details.
- \* **Hurricane Benefit:** Receive a refund for unused or interrupted vacation nights plus a future vacation discount certificate if your vacation is interrupted for 24 hours or more due to a Category One or greater hurricane. Valid for July-October departures.

- The following items are not covered Pre-Departure:
  - Revision Fees
  - "No Show" situations where the clients do not check in and denied boarding situations are not covered.

**To Obtain a Cancellation Refund:**

Once the cancellation is made before travel to the travel agent or the reservation center, a written request must be submitted to:

A refund will be processed, less the cost of Complete Coverage to the original form of payment.

**Price Guarantee Details:**

The Lowest Price Guarantee is valid on Charter/Value Air Vacations.

- The Penalty Waiver guarantees the lowest available price. Package must be the exact same - exact same room category and class of air service.
- In order to receive the lowest price advertised, call your travel agent or the reservation center at 1-800-558-3050.
- If the lowest advertised rate is a one day sale, the change must be done to the reservation on the day the one day sale takes place.
- The Lowest Price Guarantee is not available on scheduled air vacations.

**Hurricane Benefit Details:**

Hurricane Benefit Plan valid for Funjet Vacations for July-October departures. If a your Funjet vacation is interrupted for 24 hours or more due to a Category One or greater hurricane, you will receive a refund for unused or interrupted vacation nights plus a "Fresh Start" certificates for a future vacation.

\$100 per adult, \$50 per child for Charter Air/Value Air vacations\* and \$25 per person for Scheduled Air Vacations\*\*.

Vacation Vouchers are non-transferable and are not redeemable for cash and can be used on any Funjet Vacation for travel any time (excluding holidays) for one full year from original departure date.

- A qualifying disruption occurs when customers are displaced from their room for 24 hours or more due to the result of a Category One or greater hurricane and does not apply to hurricane warnings. Hurricane Plan benefit applies to unused nights or the nights you are displaced from your hotel if a comparable hotel of equal or greater hotel rating is not provided. Hurricane Plan benefits are not available for air only, land only, scheduled air, or promotional bookings.
- Please note: The policies for the air portion of the vacation will vary by airline. Airline policies will be published when a hurricane/tropical storm occurs and will be specific to that storm. Typical policies will allow you to be re-accommodated on your airline's next available return flight and/or may allow you to rebook your return to return early and waive the re-ticketing fee, subject to availability. Customers who are impacted by a hurricane while on their vacation may be eligible for benefits provided under the travel insurance portion of the plan and may contact AIG Assist for assistance with changes to their travel itinerary or contact BerkelyCare for consideration of additional expenses incurred related to a delay caused by a hurricane/tropical storm.
